**FSBM HOLDINGS BERHAD FORGES STRATEGIC PARTNERSHIPS  
WITH DATAPREP HOLDINGS BHD  
TO ADVANCE CYBERSECURITY, E-MONEY, AND SOFTWARE COLLABORATION**

**KUALA LUMPUR, 21<sup>ST</sup> March 2025** – FSBM Holdings Berhad (“FSBM” or “the Group”) (“富士通控股公司”), through its wholly-owned subsidiaries, FSBM Solutions Sdn. Bhd. (“FSBM Solutions”) and UNOS Sdn. Bhd. (“UNOS”), has signed two Memorandums of Collaboration (“MoCs”) with Dataprep Holdings Bhd (“DATAPREP”) (“泰达控股”), a listed company, to drive advancements in cybersecurity, e-money solutions, and software collaboration.

The first MoC, signed between FSBM Solutions and DATAPREP, focuses on the development and enhancement of cybersecurity and e-money solutions. Under this collaboration, FSBM Solutions will provide consultation services related to cybersecurity, e-money, and associated technologies. Meanwhile, DATAPREP will contribute its expertise in cybersecurity software, e-wallet solutions, and other relevant areas. This agreement takes effect immediately and will remain in force for five years, highlighting the long-term commitment of both organizations to bolster digital security and financial technology solutions.

The second MoC, signed between UNOS and DATAPREP, aims to foster collaboration in software development. Through this partnership, UNOS will provide consultation services for software development and other related areas, while DATAPREP will also offer its expertise in the same field. This partnership is expected to foster innovation and create synergies in software development, further strengthening FSBM’s position in the technology sector. The MoC will remain in effect for a period of two (2) years.

These collaborations align with FSBM’s strategic goals to expand its expertise in cybersecurity, e-money, fintech, and software development. By combining its strengths with DATAPREP’s

capabilities, FSBM aims to drive innovation, unlock new opportunities, and deliver significant value to stakeholders. These MoCs represent a proactive step toward positioning both companies at the forefront of digital transformation in the region.

These latest agreements bring the total number of partnership-related agreements completed by the FSBM Group since the start of 2025 to six, reflecting the Group's proactive approach to strategic collaborations and growth. These strategic partnerships underscore FSBM's commitment to enhancing its technological capabilities and expanding its market presence. The successful execution of these initiatives is expected to contribute positively to the Company's growth and long-term success.
