## FSBM Enters Key Strategic Partnership with VisionTech to Drive Generative Al Adoption in Malaysia

Branding and marketing efforts will be jointly executed, with both Parties working together on campaigns, promotional events, and digital outreach to raise awareness and generate demand for AI solutions. In fact, FSBM has already kick-started its marketing strategy through the successful launch of "FSBM's GEN AI FORUM 2025" held this morning. The forum drew participation from over 80 senior leaders and



technology specialists representing approximately 50 different companies across various industries.

Recognising the long-term potential of this alliance, the Parties have agreed to explore deeper strategic opportunities in the future. This may include initiating discussions on the potential formation of a Joint Venture (JV) entity in Malaysia. Additionally, the scope of collaboration may expand to include the development of new Al-driven solutions and technology projects that leverage the combined strengths and expertise of both organizations.

Executive Director of FSBM I- Design, Mr William Ng ("黄国强") stated: "This

agreement represents the latest in a series of strategic initiatives by FSBM to strengthen its capabilities in artificial intelligence and digital innovation. It reinforces the Group's position as a forward-thinking technology leader committed to delivering intelligent, scalable solutions that drive transformation across industries."

Founder and Chief Executive Officer of VISION, Mr Lim Hui Jie ("林晖杰"),

mentioned: "This partnership with FSBM reflects a shared vision to localize and scale our generative AI capabilities for the Malaysian market. We look forward to working hand-in-hand with FSBM I-Design to accelerate AI adoption and co-develop impactful, market-specific use cases that empower businesses to reach new heights of productivity and innovation."

FSBM's newly appointed Executive Deputy Chairman, Mr Cheong Chen Khan ("张镇瀚") has also affirmed that this partnership with VisionTech will be his first strategic project to spearhead under his leadership, signaling FSBM's renewed direction and momentum in the high-growth AI and digital transformation landscape.
